 - 3 Probationary period
 - a. Refund of initiation only if final vote is negative.
 - b. No refunds for resignations at any time.
 - c. Dues, fees, dockage, possible assessments.
 - d. Liability Insurance coverage required at all times.
 - 4 No assurance of dock availability
 - a. Dock bidding-temporary and permanent.
 - b. Member must own boat.
 - c. Club owns dock - no trading, sub-leasing - reverts to club if not used.
 - 5 Winter storage- \$50
 - a. Cradles not allowed.
 - b. Crane fee \$100 annually.
 - c. Trailers - must not be left in the yard.
 - 6 Club opens April 1st-closes November 1st - Clubhouse is accessible all year.
 - a. Bar maybe open at times if a member is present who has keys.
 - 7 Fishing rules
 - a. To be done in the authorized area, scraps to be double bagged before putting in the dumpster.
 - b. No commercial use of boat.
 - 8 Gate cards and keys
 - a. Members and immediate family only.
 - b. Extra card \$25 /keys \$5.
 - 9 Kitchen
 - a. Can be utilized by all members and are expected to clean up when finished.
 - b. Ice machines.
Members pay .50 cents per bag
Non-Members pay \$1.00 per bag
 - 10 Family club
 - a. Responsible for guests- member must be present when guests are present.
 - b. Parking and guest parking.
 - c. Childrens rules posted - life jackets required under 12 years old.
 - d. Motorhomes permitted while owner is present and in designated areas.
 - e. Member's spouse or first mate are invited to join the auxiliary membership of the Nautigals.
Dues are currently \$15.00 annually. The objective of this organization is to work together as a family unit for the pleasure and betterment of the members and their guests. Meetings are held at the same time as the regular meetings in the TV room.
 - f. Vehicle keys should be left in car or at the bar.
 - 11 Bar rules
 - a. Sales to members only-must be 21 years old.
 - b. No foul language.
 - c. No alcohol is permitted to be brought into the club house.
 - 12 Gas sales
 - a. Cannot bring or dispense fuel other than from gas pump.
 - b. Members must pump own gas.
 - 13 Work and social parties
 - a. Work parties keep cost down - members are encouraged to participate.
 - b. Members responsible for upkeep of own dock and stand-offs.
 - c. Participation is encouraged and expected at social functions-fellowship is important aspect of club.
